Commissioner moved to approve the December financial statements and journal entries as presented by Auditor Connelly. Commissioner Kress seconded. On roll call vote, the following Commissioners voted yes: Kaufman, Sather Kress and Tibert. None voted no. Commissioner Forseth was absent and not voting. Motion carried.

Auditor Connelly was directed to disconnect up to 21 customers owing nearly \$2,500 for non-payment by January 24.

Commissioner Kaufman brought the Commissions attention to an alert from Missouri River Energy Services about bills being presented in the ND legislative session that could have negative impacts on city governing and asked that city representatives call their representatives to voice opposition.

Commissioner Tibert moved to pay bills as presented. Commissioner Kress seconded. On roll call vote, the following Commissioners voted yes: Tibert, Kress, Kaufman and Sather. None voted no. Commissioner Forseth was absent and not voting. Motion carried.

Commissioner Sather moved to adjourn the meeting at 6:36 PM. Commissioner Kress seconded. Motion carried.
