On roll call vote, the following Commissioners voted yes: Kaufman, Sather, Tibert, Kress and Forseth. None voted no. Motion carried.

Commissioner Tibert moved to authorize Attorney Juelson to begin eviction proceedings after the deed was recorded. Commissioner Kress seconded. On roll call vote, the following Commissioners voted yes: Kaufman, Sather, Tibert, Kress and Forseth. None voted no. Motion carried.

Commissioner Kaufman moved to pay bills as presented. Commissioner Sather seconded. On roll call vote, the following Commissioners voted yes: Kress, Tibert, Kaufman, Sather and Forseth. None voted no. Motion carried.

Commissioner Forseth thanked Commissioner Sather for his well-written letter to the editor, encouraging residents to recycle by choice.

Commissioner Sather moved to adjourn the meeting at 6:47 PM. Commissioner Kress seconded. Motion carried.
